Attached is a radiogram from Judge, San Francisco, similar to a number of inquiries we have had from other District Office Managers. Naturally our District Offices will be besieged with inquiries from business men who will want someone to tell them if shipments to China will be safely delivered, if they are likely to get their money, if Japan will intercept all foreign trade with China, and a host of other problems. Naturally we don't know the answers. If we did we would be the wisest men in the world.

I suggest your Division send out the following radiogram to each District Office:

The Bureau has no available information sufficiently definite to serve as a safe guide to business men concerned with the situation obtaining in China and Japan, stop-Obviously conditions are highly confused, uncertain as to the direction they may take and filled with serious potentialities step Our personnel therefore must be extremely wary of committing the Bureau to any policy or advice, stop We are, however, watching the situation closely and you may be assured we will inform you immediately of any important information received end
