CONSTITUTION.

Article I-Name.

THIS Association shall be known as the Chinese Social and Political Science Association.

Article II-Object.

The objects of this Association are (1) the encouragement of the scientific study of Law, Politics, Sociology, Economics and Administration and (2) the promotion of fellowship among men of similar interests.

The Association as such will not assume a partisan position upon any political question nor involve itself in practical politics.

Article III-Membership.

The members of the Association shall be of three classes, namely; endowment members, life members and ordinary members. Any person may become a member on the invitation of the Executive Council or on the proposal of one member seconded by another and approved by the Council.

Article IV-Membership Fees.

The endowment member shall pay a fee of two hundred dollars and upwards, the life member, one hundred dollars, and the ordinary member, an annual fee of six dollars (three dollars in America or twelve shillings in England).

Each member will then be entitled during his membership to a copy of the Chinese Social and Political Science Review published by the Association.

Article V-Officers.

The Officers of the Association shall consist of a President, two Vice-Presidents, a Secretary and a Treasurer, who shall be elected annually, and of an Executive Council consisting ex-officio of the officers above mentioned and nine elected members, whose term of office shall be three years. These elected members shall be divided into three groups of three each, the term of office of the members of one of such groups expiring each year.

All officers shall be nominated by a Nomination Committee composed of five members appointed by

the Executive Council, except that the officers for the first year shall be nominated by a committee of five to be appointed by the chairman of the meeting at which the constitution is adopted.

All officers shall be elected by a majority vote of the members of the Association present at the meeting at which the elections are held.

Article VI-Duties of Officers.

The President of the Association shall preside at all meetings of the Association and of the Executive Council and shall perform such other duties as the Executive Council may assign to him. In his absence, his duties shall devolve successively upon the Vice-Presidents in the order of their election, upon the Secretary and the Treasurer.

The Secretary shall keep the records and take charge of the correspondence of the Association and perform such other duties as the Executive Council may assign to him.

The Treasurer shall receive and have the custody of the funds of the Association, subject to the rules of the Executive Council.

The Executive Council shall have the charge of the general interests of the Association, appropriate money, appoint Committees and their chair men with appropriate powers and in general possess the governing power in the Association except as otherwise specifically provided in this Constitution. The Executive Council shall have the power to fill vacancies in its membership occasioned by death, resignation or failure to elect, such appointees to hold office until the next annual election of officers.

Five members shall constitute a quorum of the Executive Council and a majority vote of those in attendance shall control its decisions.

Ten members shall constitute a quorum of the Association and a majority vote of those members in attendance shall control its decisions.

Article VII-Amendments.

Amendments to this constitution shall be proposed by the Executive Council and adopted by a majority vote of the members present at any regular or special meeting of the Association.

Rules Governing the Library

of the

Rules for The Use of The Association Library.

1. The Library is open to all members of the Association, and to guests introduced by them, on week days from 9 a.m. to 12 p.m. and from 2 p.m. to 5 p.m., and on Sundays from 2 p.m. to 5 p.m.

2. Guests not residing in Peking may be introduced on written recommendation of a member in good standing. A book is provided in which the names and addresses of each guest and of the member introducing him must be recorded.

3. Members residing in Peking who have paid in full their membership dues and guests introduced by them may draw from the library at one time not more than five volumes except reference books and valuable works which the Board of Management may withhold from use outside the library. Books so taken out must be registered with the librarian.

4. Books drawn by members or guests may be kept for one month with the privilege for renewal for one month at the discretion of the librarian. A fine of 5 cents per day shall be incurred for each volume kept beyond the period allowed.

5. No person borrowing a book from the library shall write in or mark any book belonging to the library, or turn down the leaves, or otherwise deface it. If any book is lost, one and a half times the actual cost of the volume, or of the set, if the book is one of a set, must be paid by the borrower to the librarian.

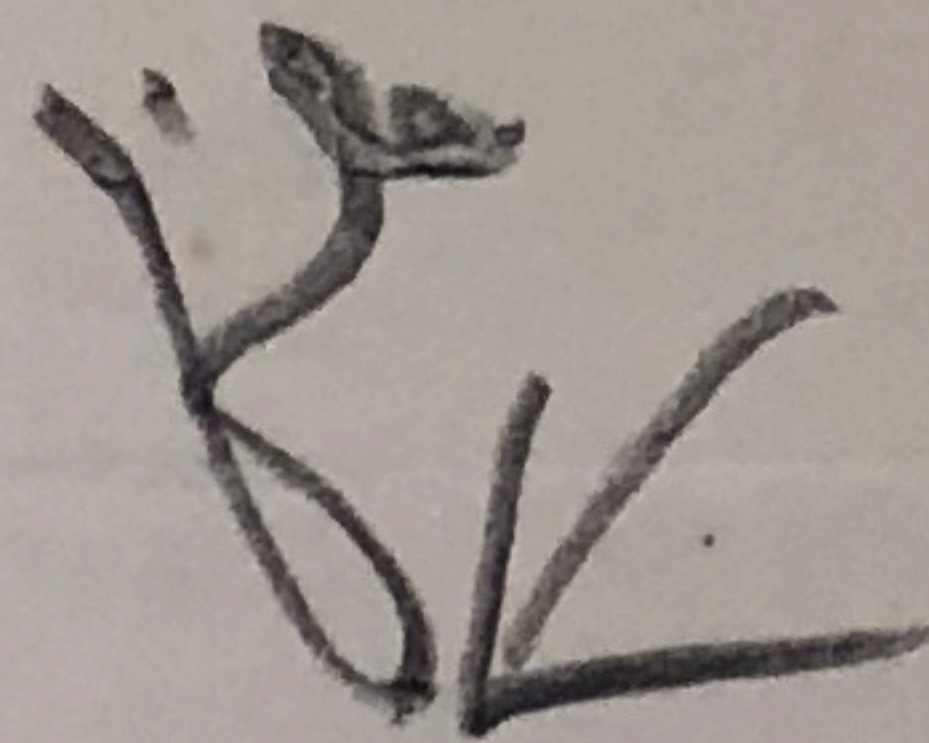
